# 2017-2018 BUS RULES AND REGULATIONS

## Rules and Regulations:

1. Students are expected to remain quiet during roll call procedures.
2. Students must respond loudly and clearly when their name and only their name is called.
3. Pre-K students must ride in the front row.
4. Students must remain seated and buckled at all times.
5. The use of electronics is permitted with headphones only.
6. No food or drink may be consumed on the bus.
7. Students may not open or close windows without permission from the bus driver.
8. Any item left on the bus will be given to the front desk and placed in lost and found.
9. Students must remain buckled in their seats at all times.
10. Parents must call or text Cailey Gray by 6:45am if student(s) will not be on the morning bus.
11. Parents must call or text Cailey Gray by 2:00pm if student(s) will not be on the afternoon bus.
12. Updated Student Information Forms must be on file with school.

## Discipline Policy:

Students who have had repeated promptings on complying with bus riding policies may be asked to sign and comply with a Behavior Contract in order to continue riding the bus.
